RULES AND REGULATIONS FOR PARTICIPATION

1) Rules of Reference

In these Rules and Regulations for Participation the term "Exhibitor" shall include all employees, servants and agents of any company, partnership, firm or individual to whom space has been allocated for the purpose of exhibiting.

The term "Exhibition" shall mean: Europe In USA Exhibition and Conference

The term "Organizer" shall mean: Europe In USA.

2) Application for Participation

1) All applications for participation shall be made on the prescribed application form which shall be submitted to the Organizer.

2) The contract shall be established when the Exhibitor submits the application form and pays the Organizer 50% of the participation fee.

3) Allocation of Exhibition Space

a) The Organizer shall allocate the space in accordance with the nature of the exhibits or in the manner the Organizer deems fit.

b) The Organizer shall reserve the right to change the space allocated to the Exhibitor at any time prior to the commencement of the build up of the Exhibition, if exceptional circumstances demand. Such changes shall be at the discretion of the Organizer and the Exhibitor shall have no claim for compensation as a result of the changes.

4) Use of Exhibit Space

- 1) Exhibitors are bound to exhibit the announced products and to man the exhibits with competent personnel during the open hours of the Exhibition.
- 2) All exhibits must accord with the description of the application form, and be related to the theme of the Exhibition. Direct sales without permission of the Organizer are completely prohibited. If the Exhibitor violates the above-mentioned rules, the Organizer may remove his exhibit or order the dismantling of his stand
- 3) The Organizer reserves the right to refuse admittance to the exhibition to any person
- 4) Exhibitors are not allowed to sub-let the space allotted to them to other parties either wholly or in part without the written consent of the Organizer.
- 5) Modifications including decoration such as painting the floor, ceiling and pillars will not be permitted, and consequent damage to the Exhibition Hall will be compensated by the Exhibitor.

1) Rules of Payment

- a) 50% deposit of the participation fee and/or relevant stand charges must be paid at the time of application by the Exhibitor. The balance shall be paid not later than 90 days prior to the opening of the Exhibition.
- b) The participation fee shall be paid on the due date. Otherwise the Organizer has the right to cancel the contract, and in this case the Exhibitor's deposit will not be refunded.

6) Breach of Contract and Withdrawal by Exhibitor

a. In the event of abandonment or rejection of the allocated space, the Organizer has the right to cancel the Exhibitor's application. In this case, the Exhibitor's deposit will not be refunded.

b) In the event of partial abandonment or rejection of the allocated space, the Organizer has the right to cancel the application or reallocate the partly abandoned or rejected space. In this case, if the participation fee for the diminished space is already paid, half of the fee is refunded. But if that fee is not yet paid, the Exhibitor should pay half of the fees applicable to the diminished space.

7) Changes

Organizer reserves the right to terminate the Exhibition if use or occupancy of the Exhibition premises are or will be materially interfered with by reason of fire, casualty, strike, embargo, injunction, acts of God, or any other emergency or any other act or event not the fault of the Organizer during any period of the time the availability of which is critical to the successful production of the fair. It is expressly agreed that such a termination shall not constitute a breach of this agreement. The Organizer reserves the right to change the venue and duration of the Exhibition if exceptional circumstances demand.

8) Construction and Decoration of Stand

All Exhibitors must complete their construction and/or decoration by the date and time stipulated by the Organizer.

9) Movement of Exhibits

Exhibitors shall remove all exhibits from the Exhibition Hall within the period stipulated by the Organizer and shall indemnify the Organizer for loss by reason of delay or damage to the Exhibition Hall.

10) Security

- a) The Organizer shall take all reasonable security precautions in the interest of Exhibitors and visitors.
- 5) The Organizer shall not be held responsible for any loss or theft or damage of exhibits at the Exhibition Hall during the build up, exhibition and dismantling periods. The Organizer shall also not be held responsible for any loss or damage to exhibits or any article belonging to the Exhibitor.

2) Fire Regulations

- a. Material used in stands and display construction must be properly fire-protected in accordance with the regulations of Fairgrounds.
- b) The Organizer has the right, should circumstances necessitate, to make changes to the Exhibitor's stand, in the interest of fire control.

3) Supplementary Clauses

- a. Whenever necessary, the Organizer shall have the right to issue supplementary regulations in addition to those in the Rules and Regulations for Participation to ensure the smooth management of the Exhibition.
- b. Any additional written regulation instruction shall form part of the Rules and Regulations for Participation; they shall be binding on the Exhibitors.
- c. The Exhibitor shall also observe EUROPEinUSA Rules and Regulations

4) Arbitration of disputes

Any dispute that may arise at any time hereinafter between the Organizer and the Exhibitor touching of the true construction of these Rules and Regulations for Participation or the rights and liabilities of the parties hereto, shall be finally settled by arbitration in accordance with the Commercial Arbitration Rules of the country. The award of the above arbitration shall be final and binding upon both parties.
